1. Call to order
2. Town Council recesses into executive session
3. The Town Council will meet in closed session regarding the following items and/or any item posted on the agenda notice for this meeting as necessary under the following exceptions to the Open Meetings Act under Texas Government Code:

Section 551.071 – to consult with legal counsel regarding pending or contemplated litigation and/or on matters in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Government Code including subdivision platting issue; roadway, drainage, and town facilities; CPDD development; Cheryl Connelly and Richard Connelly v. Town of Fairview, Hooker and Jeffry, P.C. and Tegrity Contractors, Inc., Cause No. 366-03874-2015 in the 366th Collin County District Court ; state regulations and local authority regulating the sale of alcohol.

Section 551.074 Personnel - position or appointment of members of all non-advisory boards and commissions, annual evaluation of Town Manager.

Section 551.087 – to discuss or deliberate Economic Development Negotiations: (1) To discuss or deliberate regarding commercial or financial information that the Town of Fairview has received from a business prospect that the Town seeks to have locate, stay, or expand in or near the territory of the Town of Fairview and with which the Town is conducting economic development negotiations; or (2) To deliberate the offer of a financial or other incentive to a business prospect described by subdivision (1). Proposed commercial/retail developments.

The council further reserves the right to enter into executive session at any time throughout any duly noticed meeting under any applicable exception to the Open Meetings Act.

 - a. Lovejoy High School Senior Independent Studies student, Julia Vastano, will present her research project presentation on the topic of “History of Collin County via Pecan Grove Cemetery.”
 - b. Presentation from Weaver and Tidwell regarding the annual independent audit for the fiscal year ended September 30, 2015, and take any necessary action.
7. Consent Agenda
 - a. Approve minutes of the February 2, 2016 regular Town Council meeting.
 - b. Approve minutes of the February 8, 2016 special Town Council meeting.
 - c. Amend Ord. 2013-3 calling the May 7, 2016, General Election to reflect changes in polling locations due to the cancellation of the Lovejoy ISD election.
 - d. Ratify the purchase of Fire Apparatus and approve an ordinance authorizing a budget amendment pertaining to the fiscal year 2015-16 budget and providing an effective date.

All items listed under the Consent Agenda are considered routine and will be acted on by one motion, with no separate discussion of these items. If discussion is desired, an item may be removed from the consent agenda and considered separately.

8. Public Hearings
 - a. Continue a public hearing, consider, and take any necessary action on an Ordinance granting a request by M. Christopher, Custom Homes, to rezone a portion of a 44.069 acre tract of land situated in the Robert Fitzhugh Survey, Abstract No. 317

and the Samuel Sloan Survey, Abstract No. 791 in the Town of Fairview, Collin County, Texas and being generally located adjacent to and east of Country Club Road (FM 1378) and north of Farmstead Street from Open Space and Flood Hazard (FH) Zone to Two-Acre Ranch Estate (RE-2) Zone. **(ZA2015-14)**.

- b. Conduct a public hearing, consider, and take any necessary action on a request by Carlo Strippoli, for approval of an Ordinance granting a Conditional Use Permit (CUP) in order to allow for the construction of an accessory building on a property that is zoned One-Acre Ranch Estate (RE-1) and is specifically located at 201 Dumont Ct., being Lot 9, Block A of the Thompson Springs Phase 2, to the Town of Fairview. **(ZA2016-02)**.

- a. Discuss and take any necessary action on approving additional expenditures for the Parkside Trail improvements.
- b. Discuss status of DART as a replacement for TAPS transit service and take any necessary action.
