- a. Consider and make a recommendation on a request for approval of a Minor Final Plat of the Shackleford Estates Addition. The 11.2-acre tract of land is located at the northwest corner of E. Stacy Road and Orr Road (FM 317) and is zoned for the (RE-2) Two-Acre Ranch Estate District. Applicant: Nathan Shackleford representing owners Kelly and Karen Shackleford. **Approved**
 - b. Consider and make a recommendation on a request for approval of a Final Plat of the Danielle's Crossing Addition. The 10.4-acre tract of land is located on the north side of Hart Road, east of Stoddard Road and is zoned for the (RE-1.5) One-and-one-half acre Ranch Estate District and the (RE-1) One-acre Ranch Estate District.
