The Town Council will meet in closed session regarding the following items and any item posted on the agenda notice for this meeting under the following exceptions to the Open Meetings Act under Texas Government Code:

Section 551.071 – to consult with legal counsel regarding pending or contemplated litigation and/or on matters in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Government Code.

Conduct a public hearing and take action regarding the zoning of property that is annexed but unzoned, commonly known as Advanced Tree and Shrub Care, Inc., located at 590 Meandering Way, comprised of 4.5± acres proposed to be zoned Planned Center (PC) generally located east of N. Meandering Way, west of Creekwood Circle, north of Creekwood Drive, and south of Sloan Creek Parkway.

 - 8. Conduct a public hearing on the 2011-12 ad valorem tax rate.
 - 9. Conduct a public hearing on the 2011-12 budget.
